Alcohol Impact Ordinance

The Washington State Liquor Control Board approved Tacoma's Alcohol Impact Ordinance on Dec. 12th 2001. The ordinance was approved by the City Council in October and at a hearing that was held by the Liquor Control Board on Nov. 19th. Approximately 100 people attended to voice views that were overwhelmingly supportive.

Under the ordinance, certain products which can be bought by the single container, with a fortified alcohol content and low cost-per-ounce, will be banned from sale in the AIA. Neighborhood activists, police and human services organizations maintain that these products can be linked to chronic public inebriation and its social and public costs. The AIA encompasses a large area, from the 509 corridor, all of downtown, along the Schuster Parkway to Alder, then along Highway 16 to I-5 and along I-5 to the Puyallup River.

The North Slope is in the middle of the area. The 7-11 on North I, the Shortstop Market on Division and the Corner Store on North K still sell these products. The AIA takes effect on March 1st, 2002.



Next North Slope Meeting

Our Very Own Park

The North Slope Historic District Park at North 8th & K is approaching completion at press time. It should be finished when you read this!

The park has been a project of the North Slope Historic District, the City and the North End Council. North Slope residents suggested the idea in the early 1990s, but the North Slope Historic District had no money to proceed. Our representatives on the North End Neighborhood Council eventually secured the funds from the Thea Foss Bond Issue given to each neighborhood council, but it took years to work out the transfer of the property from Tacoma Power to the City.

Metro Parks was the designing and developing agency, although the property is owned by the city. Maintenance of the property is still being negotiated by Metro Parks and the City of Tacoma. The small park contains a wooden piece of play equipment for small children, seating, handicapped ramp, and new plantings. The design and equipment in the park were approved by the Landmarks Commission, and the sign that will be put up eventually will need the commission's approval also.

A dedication ceremony is planned for May, during National Historic Preservation month. The park will be dedicated to Valerie Sivinski, former Tacoma Historic Preservation Officer who provided guidance for the creation of the North Slope Historic District.



New Steering Committee Leader

City Building Permits and Historic Preservation in the North Slope

As the North Slope Historic District representative to the Tacoma Landmarks Preservation Commission, I have been aware of a problem in the NSHD that perhaps needs some clarification. The City of Tacoma has a building code to ensure safety and consistency in systems and engineering. Whenever a residence is being altered, a permit is usually needed. There are exceptions but these are few. Call the permit desk at 591-5030 and tell them what you are considering, and they will get you started.



In the North Slope Historic District we have another set of guidelines that apply to the exterior of our homes. These guidelines help us make decisions on changes to the exterior without losing or significantly altering the historic features and character of our homes. These guidelines are the compass that keep the ever-changing NSHD from drifting too far from the unique, diverse, vibrant and historic area that we all enjoy now. There are many examples in Tacoma where a fine historic home or area was altered, and in just a few years it had

lost the features that made it special. Our guidelines keep us focused.

Once you have applied for your permit there is one more step to actually getting it. Your plan is reviewed by the Tacoma Landmarks Preservation Commission. The process is very simple. Fill out a form, get some pictures and drawings of your project, and discuss your plans with the commission. It will work with you to make them happen within the historic guidelines. Once your plans are approved by the LPC your permit will be issued.

The North Slope Historic District has had a rash of major changes made to primary and secondary historic homes without permits or LPC review. Some of the changes were done with sensitivity and common sense in respect to the historic nature of the house and neighborhood. They won approval of the LPC without a battle. On the other hand some changes were clumsy and inappropriate, and the cheapest methods of making the desired changes were employed. This approach not only devalues the home but it is a blight on the neighborhood. The neighborhood has an appearance and spirit that is easily understood, and whenever inappropriate changes are made the appearance and spirit are damaged.

The next time the weather allows, go for a walk through your neighborhood and take a close look at all the styles of architecture. Notice how changes and additions alter the look and spirit of homes. Think of all the generations of people who have lived here before and all those who will follow. It is our responsibility to preserve the NSHD so that the spirit of the Tacoma pioneers is easily understood by future generations.



Adopt-a-Spot News

The next Adopt-A-Spot litter pick up on North I Street will be Saturday, March 2nd, at 10:00 AM. If it is raining, we'll try March 9th, a week later. We will meet in the parking lot behind Immanuel Church, North 9th & J Street. There should be a lot of debris since our last pickup in August! We welcome new volunteers as well as the "old regulars!"

Adopt-a-Storm Drain

City of Tacoma wants citizens to "Adopt a Storm Drain." If you have a drain in front of your parking strip, keep it free of leaves and debris by cleaning regularly with a rake or shovel. Residents on corners can also check those drains. Heavy downpours quickly overflow many drains, and the city can't get to all of them right away.

The North Slope Historic District will help the City of Tacoma install "*Save the Bay*" stickers by storm drains in our area. We'll start in May or June, as pavement needs to be dry. The plastic salmon markers will replace the stenciled words to remind us that what is dumped down storm drains goes directly to local waterways and the bay, thus endangering salmon.
